Incentives & Discounts

PAYMENT IN FULL

Any families not eligible for the Archdiocesan Discount that choose to pay the total tuition cost as listed in the HNCS Admissions and Tuition Policy will be eligible for a 5% discount off your total tuition. To be eligible, payments must be submitted by 7:45am on Wednesday, August 7, 2018. NO ADDITIONAL DISCOUNTS OFFERED AFTER AUGUST 7th DEADLINE.

ARCHDIOCESAN DISCOUNT

If you serve as a full-time employee of the Archdiocese of Indianapolis, you receive up to a 25% discount.

We offer 3 types of tuition assistance:

Institute for Quality Education (IQE): You may apply for IQE if you live in Marion County and have a student entering Kindergarten or above and are eligible based on the financial criteria.

State Choice Scholarship (voucher): You may apply for this state assistance if you qualify financially and your student has been in public education in Indiana for the two concurrent, consecutive semesters prior to enrollment, live at an address that would otherwise send your child to a failing school, have a student that receives Special Education services, have a child that has received a voucher or scholarship from a state recognized Scholarship Granting Organizations (SGO) in the past, or have a child whose sibling has received a voucher or scholarship from a state recognized SGO in the past.

Parish-Based Financial Aid: PSAS is parish assistance; any school family may apply and assistance is awarded based on priority need and availability of funds.
